Athlete of The Month Presentation: The program began at 4:05 PM. It adjourned until 4:30 PM for food and refreshment

Quorum: President Tom Derderian called the meeting to order. He asked Secretary Steve Viegas if a quorum was established. The secretary responded in the affirmative, that a quorum had been established.

Treasurer's Report: Annual reporting was available in written form. We continue to amass assets. We are close to a break even. Prior to this year we ran surpluses. The treasurer advises that we hire an advertising/marketing person to supplement Steve's operational side.

Nick Kanaracus brought up the need for a marketing person/lobbyist.

Ron Boemker asked that if there is a proposal to spend money on such a thing that we obtain a report like that of the Office of Personnel and Management to project what benefits would accrue to the association.

Managing Director Report: Managing Director Steve Vaitones explained that the trust at Reggie Lewis Track and Athletic Center is to keep the facility current. For a more complete report, Steve referred to his written report which was available to members. The association has 156 clubs. Sanctions are now down slightly. He reviewed all the events, association and national. We will have a Level 1 Coaching School in 2016. Outdoor facilities are scarce – as are indoor facilities. We are fortunate to have Fitchburg State and Holy Cross.

Our association has full accreditation from the national organization.

At this point Steve Vaitones unexpectedly collapsed.

After emergency services arrived, provided services to Steve and removed him to the hospital, the meeting reconvened at 5:20 PM

Sports Chairs: Candidates: Zach Emerson, for Track and Field Alex Ivanov for Youth, John Barbour for Men's Long Distance Running, Mike Travers for Masters Track and Field, Jan Holmquist for Masters Long Distance Running, Lisa Doucett for Women's Long Distance Running, Paul Kirsch for Mountain Ultra Trail, George Braun for Cross Country and Justin Kuo for Racewalking. All candidates were nominated and seconded. George Braun gave a short address from George Braun?

Athletes Representative: Candidates: Richard Hartnett, Kevin Chu, Jenn Mortimer. All candidates were nominated and seconded. Richard Hartnett and Kevin Chu, a sprint specialist, each made a short address.

Moved that the Secretary cast one vote for each of the two slates. The motion passed unanimously.

Annual Meeting Delegates: Candidates Listed on the Ballot: John Babington, Ron Boemker, Laurie Boemker, Carla Coffey, Tom Derderian, Lisa Doucett, Zach Emerson, Jim Garcia, Bob Gidari, Sidney Henthorne, David Kerin, Justin Kuo, Jennifer Mortimer, Kathy Nary, John Oleski, Chris Pasko, Gary Snyder, Steve Vaitones and Stephen Viegas. It was moved, seconded and voted to add Richard Hartnett to the ballot. Paul Kirsch and Jim Burgoyne counted the ballots. All but the following were elected who are listed in the order of their vote Gary Snyder (1st alternate), David Kerin, Bob Gidari and Amanda Pasko (who was listed on the ballot as an alternate).

Long Range Process: President Tom Derderian explained the long range process we are going through. He introduced the chairs of the Marketing, Governance/Culture and Operations.

Marketing: Track and Field Chair Zach Emerson discussed Marketing's efforts. 5 point plan. The website will be updated. The association will hire an additional person to handle championship events and marketing (a sports information management person). The target is to hire by January 1, 2016.

Governance and Culture: Vice-President Chris Pasko explained the process. He reviewed the culture document regarding board meeting practice and etiquette. Chris addressed a lot of the cultural issues.

Law and Legislation Committee: A committee will review by-laws. Term limits will be studied. Former President Ron Boemker expressed an interest in serving on the committee.

Operations Committee: Vice President Jim Garcia explained the process of assembling an operations manual.

Breakout Groups: Breakout groups were not held due to the earlier emergency.

Grant Program: Amanda Wright was recognized to make a proposal regarding a grant program. The initial proposal was for \$200,000 proportioned according to clubs which grants could be used to put on a track meet, an all-women's event or a youth track event.

A debate was held about withdrawing the proposal and having a committee look into expanding the current grant proposal.

Amanda withdrew her proposal and it was:

Moved: That an "opportunity initiative grant" proposal process be brought to the board by members for large annual and semiannual grants and that the board report back to the membership in 90 days. The motion passed on a voice vote.

It was unanimously moved to adjourn. The motion to adjourn passed.
