The organization runs and supports many T&F meets, road races, cross country races, and race walks annually. It supports over 5000 members, 150 member clubs, and it sanctions (and insures) over 700 events annually. We have a professionally staffed office open all year, 5 days/wk, 8 hr/day, which answers questions from members and provides on-site, technical, and administrative support for events. We administer these services in the states of MA, NH, RI and VT. In 2015 we directed regional championship events and race series for our members.
