It supports over 4600 members, 153 member clubs, and it sanctions (and insures) over 600 events annually. We have a professionally staffed office open all year, 5 days/wk, 8 hr/day, which answers questions from members and provides on-site, technical, and administrative support for events. We administer these services in the states of MA, NH, RI and VT. In 2012 we directed National and Regional championship events and race series for our members.
