AWARDS:
Medals to top 3 finishers in each event.
One medal per event – either open or masters.

PERFORMANCE AWARDS:
Open: \$100 to top Eligible USATF-NE Athletes if scoring an IAAF 950+ point performance, T&F, Male & Female
Masters: Age 40+ \$100 to top overall Male & Female Age-Graded mark. All masters eligible.
