We have a professionally staffed office open all year, 5 days/wk, 8 hr/day, which answers questions from members and provides on-site, technical, and administrative support for events. We administer these services in the states of MA, NH, RI and VT. In 2014 we directed National and Regional championship events and race series for our members.
