It supports 6,114 members, 194 member clubs, and it sanctions (and insures) 700 events annually. We have a professionally staffed office open all year, 5 days/wk, 8 hr/day, which answers questions from members and provides on-site, technical, and administrative support for events. We administer these services in the states of MA, NH, RI and VT.
